**BREEDING CONTRACT**

**STUD FEE \$15 00.00** (inclusive of handling fee)

**BOOKING FEE \$100.00** (non refundable, non transferable, no mare will be served until this fee is paid)

**BALANCE DUE** must be paid prior to mare leaving stud.

**AGISTMENT** cost of board \$10.00 per day. The mare will be fed oaten hay twice daily (am,pm). Rugging is an extra fee of \$3.00 per day. If a hard feed is required the mare will be fed twice daily (am,pm) oaten hay and fed a hard feed of oats, barley, bran and chaff which is a fee of \$15.00 per day. Seven days agist fees are due at the time of the mare's arrival. Any mare agisted for an extended period of time charges are due and payable on departure.

**ANY MARE NOT HALTER BROKEN WILL NOT BE ACCEPTED**

**LIABILITY** All reasonable efforts will be made to provide visiting mare's and foals with proper care to insure their health and safety. However, the stallion owner, or their representatives will not be liable for any injury, accident or death to the mare, foal to be born or foal currently at their side.

**LFG** If the mare should, abort the fetus, fail to conceive or lose the foal within 20 days (a veterinary certificate is required) the mare owner is entitled to a free return service to the stallion, exclusive of any expenses (ie: handling fee, agistment and vet costs). If long term staying mare's are not to settle on the first cycle a non refundable \$100.00 fee will be charged for each subsequent cycle. If the mare is to return to the stallion another negative swabbing is required. From this date of contract the mare owner has one consecutive season in which to exercise the LFG. This is non-transferable.

**OUTSIDE MARE'S** Must have a veterinary certificate stating that they have been vaccinated for **influenza, tetanus, strangles and a negative swabbing 21 days** prior to arrival at Brookevalley Stud. Horse's or ponies will not be allowed on the premises unless they have fulfilled these requirements.

**ACCOUNTS Must be paid in full prior to the mare leaving Brookevalley Pony Stud.**
