First class starts at 8.30am. A maximum of 3 classes at a 2 consecutive heights can be entered per horse and rider combination. If you are NOT a member of G&HEA or EWA you will need to complete the Competition Membership form and pay the fee of \$10 and include this with your entry payment. **All riders, excluding G&HEA Adult Riding Division members MUST include a signed waiver with their entry.** Riders must wear approved helmet and boots whilst mounted and saddlery must fit the horse comfortably and securely.

Stables will be available. **NO HAY in the stables** and please clean your stable after use. Please pick up your horse's manure from stables and in the car park and drop at manure pit near stables or in bags provided around grounds.

Competition members are not eligible for election to the Committee, do not have the right to nominate a person for election to the Committee and cannot vote at any meetings of the Association. Protection is afforded to the member under the club’s Public & Products Liability Insurance while participating at the designated event where they are liable for bodily injury or property damage to a third party . It does NOT provide Personal Accident insurance cover.

It is important to note that any liability claim for causing bodily injury or property damage to a third party whilst attending a designated event results in a \$2,500 excess. This is excess is payable by the person held liable for the damage.
