3. All riders under 18 years must be a member of EWA to compete. (GEA Competition Membership is not available)
4. A maximum of 2 tests at the same or consecutive level can be entered per horse.
5. All riders (excluding GEA & EWA members) MUST include a signed waiver with their entry.

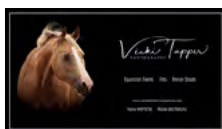

Competition members are not eligible for election to the Committee, do not have the right to nominate a person for election to the Committee and cannot vote at any meetings of the Association. Protection is afforded to the member under the Association's Public & Products Liability Insurance while participating at the designated event where they are liable for bodily injury or property damage to a third party. It does NOT provide Personal Accident insurance cover.

It is important to note that any liability claim for causing bodily injury or property damage to a third party whilst attending a designated event results in a \$2,500 excess. This excess is payable by the person held liable for the damage.

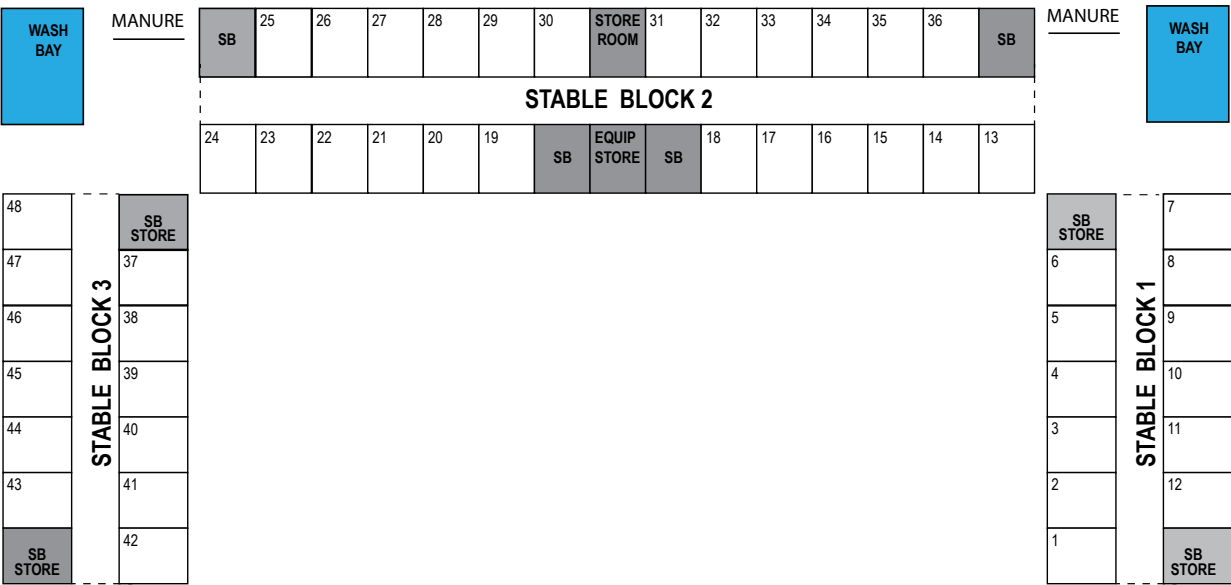
