



**Each member of a pair must complete 2 of the 4 phases, 1 or both competitors may also compete as individuals and use the scores from 2 phases of their individual entry for their pair entry. The pair entry must specify which phases are to be used for each competitor.**

#### **NOTE**

This event will be run under PCWA Tetrathlon Rules. Cross country phase to be ridden in suitable riding attire (i.e. pony club cross country uniform or equivalent e.g. long sleeved shirt, approved boots and helmet must be worn). Pony Club gear checking will be enforced for all classes.

**If you are in a pair and not competing in the cross country horse riding phase you are required to take out PCWA day insurance for \$10 and must complete the PCWA Disclaimer.**

## NOTES: PLEASE READ CAREFULLY

1. Pairs may consist of either two adult riders or one adult and one junior or two juniors.
2. All competitors must include either the PCWA Member or their current Annual Insurance number.
3. All Competitors must sign the Disclaimer attached (including PCWA members)
4. One competitor, one helper rule applies. No competitor will be allowed to compete if an individual helper is not available.

6. MEDICAL ARMBANDS COMPULSORY.
7. All competitors in all grades must wear a body protector for the cross country riding phase.
8. Age for all classes is determined on age at 1<sup>st</sup> January 2019.
9. Competitors must be at least 9 years old as at 1<sup>st</sup> of January 2019 to compete in any phase of the Tetrathlon.
10. Each competitor must supply their own bib style number holder for all phases.
11. Yards must be reserved for the weekend (\$25) by prior arrangement to [t.w.dowling@bigpond.com](mailto:t.w.dowling@bigpond.com) . Please note the yards have a single chain as the 1.2 m gate – additional rope to secure ponies is recommended. Most of the yards are now under cover and these will be allocated first.
12. The organising committee reserves the right to alter start times and or combine or cancel classes if numbers require. Please check website for updated information before event.
13. The one horse, one rider rule will apply for all classes. Horses may only jump once at one height.
14. Competitors competing as a pair and an individual must do so in the same grade.
15. Minimum age for horses 4 years
16. Dogs are **NOT** allowed at any of the venues including Dryandra Regional Equestrian Park.
17. If this event is cancelled once competition is underway due to extreme weather, there will be a no refund policy.

**Day Membership is applicable to the following compulsory points:**

- Any individual that is not a current financial Riding Member of the Pony Club WA must pay to become a Day Member to ride at any pony club rally, regardless of other affiliations and insurance held.
- Day Membership is \$10.00 per rider per fixture. \$10.00 per rider is to be sent to the Pony Club WA by the organising club along with Day Member Form. Becoming a Day Member entitles the rider to Public Liability cover for that fixture only.
- A rider may attend a maximum of 2 Pony Club Rallies as a day member and will not be covered by any insurance unless a full riding member.
- As of 1st January 2013 Day Membership is not allowed at any Pony Club WA Open event or competition (excluding unmounted phase for Tetrathlon).
