### Oakford Jump Cross

Oakford Jump Cross at Oakford equestrian Centre 434 Kargotich Rd starting at 8am and finishing approx 1230pm followed by Barbie and drinks for those that want to stay

The fences will be encouraging and the idea is to train .....and if a horse has a problem to try and solve it

There will be 5 heights 45cm, 60 cm, 70 cm, 80cm and 90cm

### Course Design

Courses will be approximately 1000-1500m in length and include up to 20 jumping obstacles, all of similar colour, but of variable style and technicality.

The course will combine the thrill of cross-country, with the technicality of showjumping.

Normally, at the last fence, there is an option to jump the joker fence, this is approximately 6 inches higher than the rest of the course. If you clear the joker, 40 penalties will be taken off your score. If you knock it down, 40 penalties will be added to your final score.
