to run last, then get your entry in first.

## **DIVISIONS**

Divisions will run in order as listed below. Please note:-competitors must be available for their walkthrough with the judge – approx. one hour before their division start.

Competitors are allowed to nominate for multiple divisions – please read the rules if you want to nominate for multiple divisions (or email us for advice).

**YOUNG GUNS:** Minimum age of 7 years – maximum age of 11 years. Any rider between the age of 7 and 11 are eligible to compete in the Young Guns Division. Young Gun riders are allowed to ride "up" into Youth Divisions with parental permission.

**YOUTH:** Minimum age of 7years – maximum age of 17 years

**NOVICE:** 18 years and older. The novice division is designed for beginner riders that are new to the sport of Extreme Cowboy Racing.

**INTERMEDIATE**: An intermediate rider is an individual who is ready to move out of the Novice Division but is not yet ready to compete in the Non-Pro Division. An individual in this division has had some competition experience in other equestrian sports.

**GREEN HORSE:** A division to bring along young horse and futurity horses.

- Green Horse Division a division to develop aged horses that are new to EXCA and Futurity horses.
- Green Horse Division for horses of any age.
- A Green Horse may be ridden by any competitor over the age of 12.
- A Green Horse can NOT be ridden in any other division.

**NON-PRO:** A Non-Pro rider is an individual that has experience as a rider but does not receive any form of compensation for riding or training horses. This definition applies to all riders over the age of 18.

**RIDE SMART 55+:** The Ride Smart Division is designed for non-professional riders over the age of 55.

**PRO:** An individual is considered a professional if he/she is aged 18 or over and receives substantial compensation or works full time riding or training horses.

**PLEASE NOTE**: The order of run, shall be determined by the reverse order of WCEC receiving entry nominations. Therefore, if you wish to run last and watch the other competitors in your division, then you must get your nominations in early. If you nominate on the day, then you will be running first in your division.
