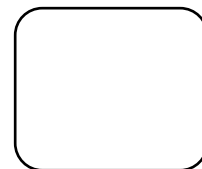

- **Nomination** fees are payable at time of nomination and are non-refundable.
- **Payment** by EFT, CHQ, MONEY ORDER , CASH accepted.
- **VENDOR payments** made not before 14 days post sale date.
- **Reserve** prices at the vendors discretion and does not have to be disclosed.
- **Yards** allocated as per arrival of nomination. As does order of sale.
- **Sale day** nominations accepted , but does not have preference over pre- nominated horses and yards.
- **Registration** papers to be available on day of sale and handed in to office. **NO** papers , will be called as unregistered. Vendor to liaise with purchaser over any other matter relating to registrations pending or otherwise. Vendor must supply contact details to purchaser for this purpose.
- **Commissions:** Horses **10% + GST** Tack & Sundries **15% + GST**
- **Livestock** must be branded for auctioning purposes. Vendor to have made them clearly visible (clip, shave).
- **Unbranded** stock can be offered by Private Treaty, with all fees as above applied.
- **Contra** fees on unreserved lots only, and at Stampede Sales discretion. Please discuss this with us.
- **Purchase** payments to be made on day of sale.
- **Passed In** lots to include tack and sundries to be collected and removed by vendor by end of sale.
- **Disclaimer STAMPEDE SALES** shall not be liable for any loss or damage sustained or incurred by any person from any loss of life, injury or damage to property or livestock, or any other act or thing done or omitted to be done wether negligently or not in and about the premises of sale facility. Any horse entered into sale/auction remains under Stampede Sales until time of sale. If sold beforehand all fees apply as per terms and conditions.
- **Safety** helmets must be worn and only vendor to ride horse/ pony.
- Any item not accounted for on purchaser invoice on day of sale will be forwarded by invoice post sale. This is collected on behalf of the vendors and needs to be reconciled.
