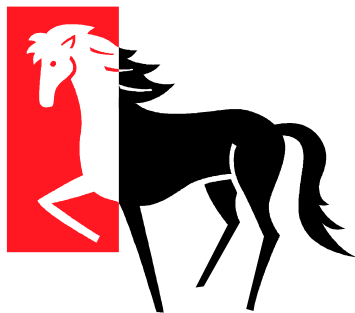

*HEIGHTS: in hand, ground poles to 15cm, 15cm to 30cm, 30cm,
50cm, 70cm*

FLAT WORKOUT: walk/trot or walk/trot/canter

Horses must be 4 Years and Over (for ridden above pole level)

OVERVIEW

The Working Hunter Event is conducted in three phases:

- Jumping
- Flatwork and
- In hand

The jumping phase is conducted first followed by Flat Work and then the In-hand. The rider and horse will move directly from one phase to the next.

This show follows the Equestrian of Western Australia, Working Hunter Rules and Competition Procedures – 2016. However, as this is an 'Encouragement Show' modifications have been made in the interests of allowing full participation and enjoyment of riders of varying abilities.

Description of a Working Hunter Type

Working hunters:

- To have correct conformation and soundness for riding and endurance.
- To have strong bone without losing quality ie; substance without coarseness.
- May have a more noble head than that a show horse.
- Can carry their rider for a full day hunting over a variety of terrain.
- Exhibit boldness, be tractable, free moving and balanced.
- Work calmly and obediently without displaying over exuberance, but still be happy and eager in their work.
- Have quality without fineness.
- Show straightness and freedom of action at all paces.
- Show boldness and natural balance.
- Have a steady temperament.
- Can be of any colour and breed

Turnout

1. Rider's Attire

- A full Working Hunter attire is not necessary – hacking jacket acceptable. Adult Rider or Pony Club uniform also acceptable.
- Riders must wear an Equestrian Australia approved safety helmet, for both riding phases and in hand.
- Dummy spurs are permitted to be worn with points down.
- Competitors may carry crops to a maximum length of 75cms.

2. Saddlery & Equipment

- **The same saddle must be used for the two phases.** Side saddles are also acceptable.
- A crupper and breast plates are permitted.
- A running martingale, bandages and protective boots are permitted in the jumping phase, but must be removed for the other 2 phases.
- No bearing reins, side or running reins of any kind are permitted
- Both phases ridden in a snaffle bridle, inhand to use snaffle bridle or halter– please contact organisers if you request to use an alternative bit.

3. Horse

- Plaiting is optional.
- False tails permitted
- Hooves may be oiled or blackened.
- No quarter markers or make up permitted.

PHASES

Jumping:

Conducted over 8 obstacles in the show jumping arena with the course open and flowing with at least one change of direction. The course includes several natural obstacles such as brush, gates and rustic rails.

Jumps to be jumped in numerical sequence.

Scoring for each obstacle:

- 3 marks = insufficient
- 7 marks = good
- 10 marks = excellent
- Knockdowns and refusal = minus 10 marks, maximum minus 20 marks, after 3 refusals move on to next jump
- Fall of rider or horse = minus 10 marks with continuation in competition at discretion of judge.

Flatwork:

See flat work out attached. This can be undertaken in walk / trot or walk/ trot /canter. Please advise judge before commencing the work out. 2 options for flat workout included. The flat workout can be done on either the left or right rein.

Remove martingales and leg protective boots / bandages.

Scoring:

- A mark out of 20 for Action and Paces
- A mark out of 15 for Manners (submission and obedience)
- A mark out of 10 for rider and horse attire

In-hand:

Horses must be unsaddled for the conformation and type mark. Horses and ponies are assessed while standing.

No workout is necessary.

Scoring:

- A mark out of 30 for hunter type
- A mark out of 25 for conformation

Note: *Event numbers are limited and will close when entries are full. 1st Round per Horse and Rider – competitive. Additional rounds can be undertaken as a ‘non-competitive’ rider*

ENTRY FEES

Entries Fees: \$70.00 One Round per Horse and Rider Combination Non-Member of BARC or Baldivis PC
\$60.00 One Round per Horse and Rider Combination Member of BARC or Baldivis PC
\$15 for additional jumping rounds

Day Insurance: \$10.00 per Rider (N/A for Baldivis ARC Members)

Ground Fee applies: \$10.00 per horse non-members

First Aid: \$5.00 per rider

Course open for walking from 9.00am to 10.00am Sunday morning.

RULES

1. The course will consist of 8 jumps in the show jumping arena. Flat workout and in-hand in enclosed grass area.
2. There will be NO ELIMINATIONS for refusals. After 3 refusals rider, may move on to next obstacle or as / when directed by judge.
3. No elimination for a fall of horse or rider, however continuation with the round at the discretion of the judge and if required a first aid clearance.
4. Snaffle bits
5. Martingales, bandages and boots to be removed for flat workout.
6. Hacking jacket or adult riding club or pony club uniform to be worn.
7. Plaiting optional, no quarter marks or makeup
8. Prizes – ribbons to 6th place and prize for 1st place for each class.

CONDITIONS OF ENTRY

- Each horse may only be entered for one round as competitive, additional rounds are 'non-competitive'.
- All gear must be safe and serviceable. No Gear Checking. Gear safety is the responsibility of the Rider or the Rider's Parent/Guardian (if under 18 years).
- All competitors to be BARC members, or purchase the Day Insurance. All competitors must sign a Waiver Form. (EA or PCAWA insurance is NOT applicable for this event)
- The organisers/committee of the Baldivis Adult Riders Club reserve the right to cancel, alter or combine any events they seem necessary on the day.
- Riders must wear a current approved safety helmet & riding boots at all times whilst mounted on their horse/pony, and while undertaking the in-hand class. Adult Riders uniform or formal attire.
- Rider's age will be as at the day of the event.
- Stallions must be under control at all times, riders must be 16 years and over. All other competitors to be aware that stallions may be on the grounds & respect their space. Stallions must be clearly identifiable at all times and must wear a green disk.
- The Baldivis Adult Riding Club reserves the right to interpret all rules & make a decision where any dispute arises.
- The Baldivis Adult Riders Club and its committee, judges, officials, DO NOT accept liability for any accident, loss, damage, illness or injury to horses, owners, riders, spectators or any other person or property whatsoever. Entry to the grounds is at your own risk and the 'Waiver of Liability' form must be signed by all entrants prior to participation; this is a condition of our insurance.
- Strictly No Dogs.
- All Rubbish, manure and hay is to be cleaned up prior to leaving the grounds.
- Horses to be over 4 years old.
- All riders must be present at the draw time allotted.
- Venue will be open at 8:00am on the day of the event.
- Mounts which in the opinion of the club coach coordinator or their nominee are considered unsafe or unsuitable can be prevented from competing at this event.
- No entry is accepted until payment is made in full.
- **VET** - A vet will not be at the event; however closest vet is Baldivis Vet Clinic.
- **FIRST AID** - There will be a first aid post for the day. Ambulance will only be called in, as required. Riders, Parents / Guardians will be responsible for any cost incurred by calling an ambulance, or subsequent medical treatment. No mid competition Substitution of Riders is accepted under any circumstances.
- **WITHDRAWALS | REFUNDS** - Please notify the organizer if you are withdrawing, refunds will only be given upon submitting vet or doctors certificate.
- Safety and wellbeing of riders and horses is paramount, no dangerous riding will be accepted, riders are to treat their mounts in a kind & encouraging manner.

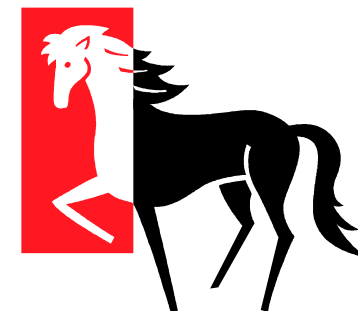

In consideration for being permitted to participate in any way in horse sport activities, I/we, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this activity/event.

I/we confirm the Recreational Service Supplier has explained this document to me/us and I/we am/are aware of the implications, intent and effect of agreeing to and signing the document. I/we furthermore confirm I/we am/are aware of the obvious risks associated with activities involving horses and I/we knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Recreational Service Supplier (hereafter referred to as the "Releasees") or others and **I/we voluntarily PARTICIPATE** at my/our **OWN RISK** and assume sole responsibility for any injury, death or property damage I/we may suffer that arises from my/our participation in horse sport activities.

I/we understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I/we take full responsibility for any injury, loss or damage associated with their consumption. I/we agree not to drink alcohol or take drugs prohibited by law before or during this activity/event.

I/we agree to follow the directions given to me and that any misconduct or refusal by me to follow any direction can result in the **CANCELLATION** of participation in the activity and my/our immediate removal from any horse **NO MATTER** where that may occur. I/we understand that any such non-compliance may result in injury, death and/or permanent disability and I/we agree to indemnify the Releasees against all claims made by any person as a result of my/our failure to comply.

I/we agree to wear a helmet at all times whilst riding and agree that I/we am/are solely responsible for ensuring that I/we wear a suitable helmet at all times and take sole responsibility for my/our actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS AND AGREE NOT TO SUE the Recreational Service Supplier, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

Agreement to exclude, restrict or modify your rights:
