

CONDITIONS OF ENTRY

Entry to this show is done with your knowledge that a pandemic named Covid-19 is still active in Australia and neither the Affiliate, the Pinto Horse Society (WA) Inc. or the Committee will be held liable for any Covid related incident that may occur as a result of participation.

- ** Covid 19 restrictions will be in place:
 - Pre-entry only no entries on the day.
 - All competitors, their helpers and their spectators will be required to provide their names and phone numbers for potential future tracing.
 - Social distancing must be maintained.

Riding on the grounds is NOT permitted if you are not entered

Maximum of 2 tests per rider & horse combination either same level or 1 level higher and riders must ride at the level either they or their horses' are eligible for. Horses and/or riders deemed to be competing at an unsuitable level by the organising committee may not have their entries accepted. If riding the same test twice, only the first test will go towards placings.

In the event where two tests are ridden at the same level, only the first test ridden will be counted towards any placings.

Only 1 rider may ride a horse on any day.

Dressage rules as per EA Australia, but specific show rules and/or the Pinto Horse Society (WA) Inc. related rules take precedence.

Plaiting and formal attire preferred. Boots, bandages and bell boots may be worn during warm up but must be removed before being gear checked and entering your test.

The Pinto Horse Society (WA) Inc. reserves the right to cancel/modify the event without prior notice as they see fit.

Draw will be emailed to all competitors by the Friday before the event.

Placings will be awarded to 6th place in each level sections.

INSURANCE: Non-members of the Pinto Horse Society (WA) Inc. or do not have insurance (see forms) must pay the registered Participant Day membership of \$15 and complete the appropriate form/s (attached).
