Conditions of Entry

1. The organisers shall not be liable for any financial loss or damage, physical injury or property damage suffered by any exhibitor/spectator with respect to any property/exhibit being exhibited by him/her or any other exhibitor, whether caused by or attributed to the negligence of the Associations or any of its servants or agents. The Associations shall **not** be held responsible for any accident that may be caused by an exhibitor or spectator.
2. All competitors entering in the Off The Track WA classes must submit their horses OTTWA Passport number. Passports can be obtained through the Off The Track WA website. Entries received without the passport number will not be eligible for any OTTWA prizes.
3. A signed Waiver **MUST** Accompany the Entry Form and is compulsory for all riders. Entry forms received without a signed waiver will **NOT** be accepted.
4. Incorrect or incomplete entries and/or insufficient payment will result in entries being returned for correction and must be returned to the Organising Committee by the close of entries or will not be accepted, The Organising Committee reserves the right to refuse/cancel or accept conditionally any entry.
5. The use of prohibited or performance enhancing substances is not permitted under any circumstances. Horses may be swabbed randomly. Positive results will be subject to penalties as per EWA guidelines.
6. The Judge's decision is final.
7. All ridden horses **MUST** be a minimum of 3yrs of age.
8. Horses age calculated from 1st August.
9. Unruly, dangerous or diseased exhibits may be asked to leave the grounds.
10. Stallions are **NOT** permitted on grounds.
11. Safety Standard Approved current helmets and riding boots **MUST** be worn at all times while mounted.
12. No refunds will be given unless accompanied by a vet or medical certificate - a \$10 admin fee will be withheld by the organisers.
13. The Organising Committee reserve the right to divide, combine or cancel classes, based on entries.
14. Entries will close on the 27th of February at 5pm.
15. No horses may be ridden on the grounds unless entered to compete.
16. **5 CLASSES MAXIMUM PER HORSE.** Rounds may include 2 dressage tests and 3 jumping rounds, or games entry, 2 jumping rounds and 2 dressage rounds etc.
17. Maximum two horses per rider.
18. Games entry covers all 6 games - this is considered one class towards the maximum 5 per horse.
19. Sponsored winners rugs will be available for classes 30cm - 115cm in show jumping, and all tests for dressage.

Release and Waiver of Liability

Horse Sports are a Dangerous Activity

In consideration for being permitted to participate in any way in horse sport activities and in particular this event, I, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this event.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of The Equestrian Federation of Australia and/or the event organiser (hereafter referred to as the "Releasees") or others and I **voluntarily PARTICIPATE** at my **OWN RISK** and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this event.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the **CANCELLATION** of my participation in the event and my immediate removal from my horse **NO MATTER** where that may occur. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst participating in the sport where this is required under the relevant EFA and FEI rules and regulations, and agree that I am solely responsible for ensuring that whilst participating I wear a suitable helmet at all times where required under the relevant EFA and FEI rules and regulations, and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue The Equestrian Federation of Australia and/or the event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise.

Effect of this Document

I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind. I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Releasees, to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.
