OVERVIEW

The Jump-Cross course will consist of approximately 20 obstacles located in the grassed show jumping arena and out on the cross-country course. The course commences with short course of show jumps before competitors continue the course over the cross country obstacles before re-entering the grassed arena to complete a further set of show jumps to complete the course. The whole course is ridden as one round from start to finish. You must present to the Judge prior to starting and after completing your round.

If 3 refusals are incurred at any one obstacle then competitors may continue to the next obstacle. We encourage all riders to try and complete the course, there are no eliminations for refusals on course.

There will be an optimum time for speed for each class, depending on distance and the judges allocated safest speed for the course. Faults will be allocated for time deviation from the optimum time, refusals and show jumping poles down. Watches and timing devices are not permitted, riders must rely on their judgement to ride the course at the optimum time. The length of the course and the judge's speed allocation will be provided once the course has been erected, measured and calculated. As a guide, the poles-30cms class will be a steady trot and the 80cms will be a forward going canter.

'The Joker' – After passing through the finish flags at the completion of the course there will be an option to attempt 'The Joker' fence which will be 10 - 15cms higher than the class height.

- Poles to 30cm Class Joker fence 40cms
- 45 cm Class Joker fence 60cms
- 65 cm Class Joker fence 80cms
- 80 cm Class Joker fence 90cms

Please present to the judge on completion to advise if you wish to remain on your current score or attempt 'The Joker' fence. If attempting the joker fence you will have 45 seconds to complete the jump from the time the judge rings the bell or the attempt will be deemed a fail.

The class winners will be those closest to the optimum time, with the least faults.

Fault Points:-

- Deviation from optimum time = 1 fault penalty per 5 seconds deviation
- Show Jump pole down = 20 fault penalty per jump
- Refusal at any Jump = 40 fault penalty per refusal
- Failed attempt at Joker (pole down or refusal) = 50 fault penalty
- Successful attempt at joker (clear) = minus 50 faults from total score

Examples of how the scoring works

Clear round on optimum time and clear joker = - 50 faults (best possible score)

Clear round on optimum time and no joker = 0 faults

Clear round on optimum time and failed joker = 50 faults

2 poles (40), 2 refusals (80), 10 second time dev (2) = 122 faults

2 poles (40), 2 refusals (80), 10 second time dev (2) and clear joker (-50) = 72 faults

2 poles (40), 2 refusals (80), 10 second time dev (2) and failed joker (+50) = 172 faults

Rules

If retiring on the cross country course, please walk horses back to the grounds following a designated track. Please report to the office if retiring and all riders suffering a fall must report to the St Johns Ambulance for a health check as soon as practicable. If you are seriously injured on course please stay where you are the First Aid Officers will be sent to assess and treat you immediately.

Gear checking is each riders individual responsibility, all gear must be safe and suitable for the purpose of the competition. Riders must be suitably attired and wear an approved helmet and body protector while during all rounds. Long sleeved shirts are recommended. Riders must bring their own competitor number bib (numbers will be provided at sign in) and horses must wear a either a bridle, saddlecloth or breastplate number.

Safety and wellbeing of riders and horses is paramount. No dangerous riding will be accepted, and harsh treatment of horses including the excessive use of whips may result in elimination from the competition at the judge's discretion.

Riders may complete up to 2 rounds per horse, if nominating for 2 rounds in the same class then the second round will be non-competitive. Riders may enter no more than 2 horses in this event.

Other Information

Warm up will be in the sand arena in front of the clubrooms, warm-up jumps will be provided. The number of horses in the warm up area will be restricted to ensure safety with precedence given in the competition draw order.

The grounds will be open from 7am on the day of the event and course will be open for walking from 7am - 8.45am. There will be a short opportunity to walk the course between each class. Walking the course is not permitted whilst riders are competing.

Gated float parking is available on the grounds accessed from Lugg Road (gate 2) and this is the safest location for your horses. Personal float yards are not permitted in the gated float park, whilst unattended horses must be tied to a float which is hitched to a vehicle or secured in a yard. Members have free access to the yards within the grounds but must pre-book by indicating one is required on the entry form. Non-members may hire a yard at a cost of \$10 (please include on your entry form and payment).

There is additional float parking on the grass verge on Tinson Road, you may erect personal yards here subject to available space. Please ensure horses in this area are safely secured as there is no gate to protect them from escaping onto the road. Please also note that this area adjacent to the show jumping arena and therefore will be a high traffic area for spectators/marshals etc.

Compulsory Helper Duties

All riders must bring a helper on the day (aged 13 or over) to assist with the safe and timely running of the show. Preference for helper duties can be selected on the entry form and will be accommodated if possible. There is an option to pay a no-helper levy of \$30, please ensure you include this payment in addition to the entry fees.

Withdrawals/ Refunds

Please notify the organiser as soon as possible if withdrawing from the competition. Refunds will only be approved on the submission of a Doctor or Vet certificate or at the committees discretion. Refunds take time to process, therefore patience are appreciated in this regard.

Clean-up

All riders must clean up after themselves and their horses prior to leaving the grounds. Please place all manure and leftover hay etc. in the muck trailer and rubbish in bins provided around the grounds.

<u>Vet</u>

A vet will not be in attendance at the event, the closest horse vet facilities are Baldivis Vet Clinic and Larkhill Vets both located within 10 minute drive of the grounds.

First Aid

There will be a St John Ambulance post for the duration of the event, funded by the City of Rockingham's community grants program.

Ground Fee

A ground fee payment is required for all horses using the grounds, it is payable per horse and is included in your entry fee. This fee goes directly to the Pony Club to help fund the ongoing upkeep of the grounds and facilities. The fee is \$5.00 for members and \$10.00 for non-members.

Medical Info and Emergency contact

You must complete this information on the entry form, this will be held at the office in case of emergency.

Insurance Waiver and Payment Info

Non-members must complete the Insurance waiver and submit it with the entry form. Payment must also be made before submitting your entry with the payment reference details provided on the entry form.

Draw

The draw will be made available on Wednesday 10th March and will also include helper duty details.

<u>Prizes</u>

Rosettes will be awarded for 1st to 6th place winners for each class. Completion ribbons for all competitors who complete the course.

DOGS ARE NOT PERMITTED ON THE GROUNDS AT ANY TIME.
