The organizers of the show have the right to refuse entry to any person, or to demand the immediate departure of anyone considered to be behaving in an unsuitable manner. Competitors are not permitted to enter the ring once judging has commenced.

## THE COMMITTEE RESERVES THE RIGHT TO ALTER THE PROGRAM WITHOUT PRIOR NOTICE

Led Presentation – all horses must be presented in a show bridle with reins or lead and a show slip for juniors. Halters are not permitted for led classes. Colts/Stallions may be left with a flowing mane and tail. Race Conditioned and Junior horses likewise are not required to be plaited. Mares and geldings must have plaited/hog manes with tails plaited, shaved or pulled. Stallions must be bitted and handler carry a whip at all times. No junior is permitted to ride, handle or be responsible for the care of an entire horse. Whips are not to be used in handler classes.

## Ridden Presentation of Horse & Rider:

Horse presentation is that of Led horses with the exception that *all horses* must be plaited. Jacket, stock/tie, vest, breeches, boots, gloves should be clean and color coordinated to match horse. Helmets must be approved and not expired. Junior riders are not permitted to use long boots in their rider classes. Number holders may be used.

## Notes for entering Classes:

**OPEN HANDLER Classes** – Open to all handlers of Pure or Partbred Thoroughbreds. Ring 2 will not start until the completion of all handler classes are completed.

**OPEN RIDER Classes** - Open to all riders of Pure or Partbred Thoroughbreds. Ring 2 will not start until all rider classes are completed.

*Purebred Led Classes* – you can only compete in one section. Junior, Race Conditioned or Senior Gender *Race Conditioned* – this section is for horses that have raced or trialed within the last 45 days. You must state the date the horse raced/trialed and provide proof for verification. You cannot enter any other Section – Junior, Stallion, Mare or Gelding

*Show Hack/Show Hunter classes* – you can only compete in Show Horse OR Show Hunter in the led and ridden, NOT BOTH. Please select the section that best suits your horse.

**TPPHSWA SPORTHORSE** – these classes are for Purebred Thoroughbred horses that are registered with The Thoroughbred Pleasure & Performance Horse Society of WA. The owner/exhibitor must be a current financial member. Proof of Membership & Registration must be provided.

## ALL PARTRED THOROUGHBRED ENTRIES MUST PROVIDE A COPY OF TPPHSWA REGISTRATION PAPERS AND CURRENT MEMBERSHIP CARD.

ALL PUREBRED THOROUGHBREDS MUST PROVIDE AN ASB PRINTOUT OR OTT PASSPORT.

ALL TPPHSWA SPORTHORSE ENTRIES MUST PROVIDE A COPY OF REGISTRATION PAPERS AND CURRENT MEMBERSHIP CARD.
