Divisions Explained

LEAD-LINE: Any ages up to 7 years of age. Can ride a maximum of 2 horses. Course will contain 8 obstacles rated 1-2.

YOUNG GUNS: 7 to 11 years of age. Any rider between the age of 7 and 11 are eligible to compete in the Young Guns Division. Young Gun riders can ride “up” into Youth Divisions with parental permission. Young Guns can ride a maximum of 2 horses. Course will contain 8 obstacles rated 1-2.

YOUTH: 12 to 17 years of age. Can ride a maximum of 3 horses. Course will contain 13 obstacles rated 1-4.

GREEN HORSE: A division to bring along young horse and futurity horses.

- A division to develop aged horses that are new to EXCA and Futurity horses.
- For horses of any age.
- A Green Horse may be ridden by any competitor over the age of 12.
- A Green Horse can NOT be ridden in any other division.

Course will contain 10 obstacles rated 1-3.

NOVICE: 18 years and older. The novice division is designed for beginner riders that are new to the sport of Extreme Cowboy Racing. Course will contain 10 obstacles rated 1-3.

INTERMEDIATE: An intermediate rider is an individual who is ready to move out of the Novice Division but is not yet ready to compete in the Non-Pro Division. An individual in this division has had some competition experience in other equestrian sports. Course will contain 13 obstacles rated 1-4.

NON-PRO: A Non-Pro rider is an individual that has experience as a rider but does not receive any form of compensation for riding or training horses. This definition applies to all riders over the age of 18. Course will consist of 13 obstacles rated 1-5.

RIDE SMART 55+: The Ride Smart Division is designed for non-professional riders over the age of 55. Course will consist of 13 obstacles rated 1-5.

PRO: An individual is considered a professional if he/she is aged 18 or over and receives substantial compensation or works full time riding or training horses. Course will consist of 13 obstacles rated 1-6.

Waiver and Release of Liability

I _____ Acknowledge and understand that participating in West Coast Cowboys events is dangerous and the risks and hazards associated with equine events, natural hazards and other hazardous activities being conducted on the premises may result in injury including death. Prior to undertaking any such recreational activity, I ensure I am aware of all the risks involved including those risks associated with any health/medical condition I have. I understand that horse riding and participation in horse related activities is/are dangerous recreational activity and horse and cattle can act in a sudden and unpredictable (changeable) manner, especially if frightened or hurt.

I agree to not be under the influence of any alcohol or drugs, that may have an effect on me and effect my responses and abilities to ride or handle a horse.

I agree that any minors in my care are entirely my responsibility and not that of any other persons. I hereby expressly assume all risks of harm to which I and those minors accompanying me may be exposed to while observing on the premises and/or participating in West Coast Cowboys Events. I release all liability for negligence and gross negligent acts or hazardous conditions including uncontrolled acts of other guests, participants, spectators and livestock.

I agree that I am responsible for my own safety, belongings and any horse/s in my care. In the event of Equine influenza, Hendra Virus or any contagious virus and subsequent lockdown I am responsible for the care and wellbeing of my horses/ponies. I Agree to comply with the DPI regulations and am responsible for any costs involved. If my horse/pony has been deemed ill by a West Coast Cowboys committee member, I will agree to leave the property with my horse/pony immediately if asked.

I agree to follow the direction of any event organiser or official and that any misconduct or refusal by me can result in the cancellation of my participation and my immediate removal from my horse no matter where that may occur and that I may be required to leave the premises immediately.

I agree that all riders under the age of 18 must wear an approved riding helmet. In the case I am over 18 years of age it is solely my decision to wear or not to wear an approved riding helmet and release West Coast Cowboys and their respective owners, officers, agents, sponsors, representatives, employees, volunteers and owners/lessees of property that I ride on at WCC events for any liability against my decision.

I hereby expressly assume all risks and hereby knowingly release West Coast Cowboys and their respective owners, officers, agents, sponsors, representatives, employees, volunteers and owners/lessees of property that I ride on at WCC events, from all claims of negligence, gross negligence and liability.

I agree to indemnify and hold harmless West Coast Cowboys and their respective owners, officers, agents, sponsors, representatives, employees, volunteers and owners/lessees of property, from any and all claims, demands, causes of action and damage, whether or not caused by their negligence or gross negligence.

I release liability of West Coast Cowboys and committee members, indemnity agreement of spectators and participants, and, waiver of any compensation for video recording and/or photography.
