1. **PRE ENTRIES CLOSING DATE: 11:59PM 25th AUGUST 2022**
2. **ALL EXHIBITORS/OWNERS/HANDLERS MUST BE A CURRENT 2022 FINANCIAL MEMBERS OF AMHS Inc**
However if you are not there is the option to pay a "\$10 Day Membership'. This is for people to come and compete at our show and see if AMHS Inc is right for you.
3. NO REFUND OF ENTRIES WILL BE GIVEN UNLESS VET/DOCTOR CERTIFICATE IS PROVIDED OR CHANGE OF DATE DUE TO COVID
4. ON THE DAY ENTRIES WILL BE ACCEPTED WITH AN EXTRA FEES
5. ALL PRE-ENTRY FEE'S MUST BE PAID IN FULL & RECEIVED NO LATER THAN CLOSE OF ENTRIES
6. ANY OUTSTANDING FEE'S/PAPERWORK NOT RECEIVED BY SHOW DAY, THE EXHIBIT WILL BE REFUSED ENTRY INTO THE SHOW
7. NO EXHIBIT WILL BE CHANGED OVER OR REMOVED ONCE ENTRY IS RECEIVED UNLESS VET CERTIFICATE IS PROVIDED, SO PLEASE CHOOSE WISELY
8. All sections of the Entry Form MUST be completed, including signing the Show Rules waiver.
9. All horses must hold CURRENT registrations with a recognised society and be owned by the exhibitor. Other Association/Society Pending horse/pony registrations will **NOT** be accepted. AMHS pending registrations only accepted if paperwork is **WITH the AMHS INC registrar**. A copy of BOTH sides of registrations must accompany entry form for horses NOT registered AMHS. Incomplete entries will be returned and will incur a re-processing fee. COMPLETE entries must be received by the due date or will not be processed. Please ensure you allow sufficient time and double check all entries. Exhibits registered AMHS INC must have registration status brought up to date including transfers even if holding current registration with another society
10. Direct Deposit payments: Please ensure that you include the direct deposit show code, which should be YOUR SURNAME only Direct Deposit payments will only be accepted if a copy or receipt of payment is included.
11. Once your entries have been processed you will receive a confirmation email (please ensure that your email address is included clearly on your entry form).
12. **PROTESTS**
Any protest must be in writing and accompanied by \$50 protest fee which will be returned if protest is upheld. Protest on rules must be lodged within 30 minutes of class completion.
No Protest will be accepted in regard to a horses/ponies height once an official measurement has been completed and recorded at an AMHS Inc. show.
13. **DRESS CODE**
Exhibitors must be suitably attired for the occasion. Suitable attire includes quality dress slacks or trousers and plain short or long sleeved blouse/shirt. Ties, hats and jackets or coats are to be worn at discretion of the exhibitor. For formal occasions, long sleeve button down blouse/shirt with slacks/trousers or skirt seem appropriate. Suitable footwear is always necessary, only boots or closed toed shoes are allowed. No advertising matter that refers to a stud, training complex or personal identification, shall appear on any items of dress, horse rugs or equipment in the ring.
14. **AMHS SHOW RULES**
All show rules applicable to AMHS Inc. and as directed by Show Management shall apply to this event. It is a condition of entry that you accept these rules and any amendment made there to.
15. **AMHS INC CODE OF ETHICS, CONDUCT & BULLYING**
All competitors are bound by the AMHS Inc. Code of Ethics Conduct & Bullying by entering this show. Any displays of bad sportsmanship or disrespect including but not limited to, leaving the arena before directed by the steward, leaving the arena before placement of all ribbons, refusing to accept a placing, disrespectful remarks made to the judge, steward or other exhibitors or any other conduct deemed by show management or committee to be a breach of the AMHS Inc. Code of Ethics, Conduct & Bullying will result in that exhibitor being disqualified for the remainder of the show including all horses entered by that exhibitor. It may also lead to further disciplinary action by the National Committee.
16. **USE OF WHIPS/CANES AT AMHS INC SHOWS**
All whips/canes used in halter classes must be no more than 70cm in length. In Harness/Driving classes the whip length should not exceed past the shoulder of the horse. Please ensure your whip/cane complies with these requirements as random measuring of whips/canes may take place at AMHS Inc. events. Any breach of this policy may result in the disqualification of that competitor from the show ring for the remainder of the event.
17. **INVALID PAYMENTS**
Invalid direct deposit or cheques will be regarded as a serious offence and a processing fee will be charged for every returned cheque. All debts must be paid including the re processing fee before entries will be accepted
18. **PHOTOGRAPHY**
AMHS Inc. may appoint an official photographer for the show. No other photographers will be permitted into the arena
19. **VOLUNTEERS**
We are always looking for helpers for AMHS Shows & Events. If you can spare some time to assist at the show, please contact us prior to the show or on the day. All assistance is appreciated.

20. OFFICAL MEASURING will NOT TAKE PLACE AT THIS SHOW

All senior horses/ponies 5 years and older are eligible to obtain a permanent height card (so you don't have to be measured at every show). It is highly advised that members attending AMHS feature shows prior to the State Show have their horses/ponies officially measured. Download a form from the AMHS website www.amhs.com.au and take with you to measuring prior to the State Show weekend. IMPORTANT NOTE!!! REGARDING NEW ELIGIBILITY FOR CLASS ENTRY & MEASURING PROCESS – 1st August Birth Date

Horses and ponies must be entered in their respective classes according to their age at 1st August. All exhibits must fulfil height for age requirements (based on 1st August age) excluding Miniature/Appendix Ponies who are not subject to height for age requirements. All exhibits MUST show according to height measured. Substitutions will NOT be accepted. All equipment including halters, sulkies, harness must conform to safety standards and comply with all insurance obligations. MEASURING AND SENIOR HEIGHT CARDS, All exhibits must be measured, unless your horse/pony has a permanent height card, to be eligible to compete. All exhibits excluding purebred American Shetlands & Miniature/Appendix Pony will be measured at the last hair of the mane.

AUTHORITY OF SHOW COMMITTEE

The Committee reserves the right to

- a) Reject or cancel any entry at any time
- b) Prohibit the participation by any person or Exhibit in any event or class for which it is entered
- c) Cancel, combine or divide any event or class

- d) Alter the time at which any class or event is to take place
- e) Transfer an Exhibit from any class to any other class
- f) Act upon any report of cruelty to any Exhibit on the Show ground

AMHS INC HEIGHT FOR AGE REQUIREMENTS

ALL exhibits will be measured from 1st August Birth Date
All exhibits excluding purebred American Shetlands & Miniature/Appendix Pony will be measured at the last hair of the mane.

MINIATURE HORSE

WEANLINGS - Horses up to and not including 12 months of age shall not exceed 30" in height
YEARLINGS - Horses 12 months up to and not including 24 months of age shall not exceed 32" in height
TWO YEAR OLDS - Horses 24 months up to and not including 36 months of age shall not exceed 33" in height
MATURE HORSES - Horses 36 months and over shall not exceed 34" in height

SMALL, LITTLE & FOUNDATION HORSE

WEANLINGS - Horses up to and not including 12 months of age shall not exceed 34" in height
YEARLINGS - Horses 12 months up to and not including 24 months of age shall not exceed 36" in height
TWO YEAR OLDS - Horses 24 months up to and not including 36 months of age shall not exceed 37" in height
MATURE HORSES - Horses 36 months and over shall not exceed 38" in height

Little Horse Height For Age Requirements

WEANLINGS - Horses up to and not including 12 months of age shall not exceed 38" in height
YEARLINGS - Horses 12 months up to and not including 24 months of age shall not exceed 40" in height
TWO YEAR OLDS - Horses 24 months up to and not including 36 months of age shall not exceed 41" in height.
MATURE HORSES - Horses 36 months and over shall not exceed 42" in height.

Foundation Horse Height for Age Requirements

WEANLINGS - Horses up to and not including 12 months of age shall not exceed 44" in height
YEARLINGS - Horses 12 months up to and not including 24 months of age shall not exceed 46" in height
TWO YEAR OLDS - Horses 24 months up to and not including 36 months of age shall not exceed 48" in height
MATURE HORSES - Horses 36 months and over shall not exceed 50" in height

MINIATURE, SMALL & LITTLE PONY

The Australian Miniature Pony (AMPR) shall be measured at the highest point of the wither. The pony must stand naturally with all four hoofs standing squarely on the ground. The AMPR shall recognize three height divisions

Miniature Pony Height Requirements

ALL AGES - Australian Miniature Pony must not exceed 34" in height irrespective of age
Any Pony upon their four-year-old (Adult) measurement that records a height of 33" or more is to be remeasured at age six years and before reaching age seven years

Small Pony Height Requirements

ALL AGES - Appendix Ponies are over 34" not exceeding 38" in height irrespective of age
Any Appendix Pony upon their four-year-old (Adult) measurement that records a height of 35" or more is to be remeasured at age six years and before reaching age seven years

Little Pony Height Requirements

ALL AGES - Appendix Ponies are over 38" not exceeding 42" in height irrespective of age
Any Appendix Pony upon their four-year-old (Adult) measurement that records a height 37" or more is to be remeasured at age six years and before reaching age seven years

PUREBRED AMERICAN SHETLAND

"UNDER" Category Height for Age Requirements

WEANLINGS - Horses up to and not including 12 months of age shall not exceed 38" in height
YEARLINGS - Horses 12 months up to and not including 24 months of age shall not exceed 40" in height
TWO YEAR OLDS - Horses 24 months up to and not including 36 months of age shall not exceed 41" in height
MATURE HORSES - Horses 36 months and over shall not exceed 42" in height

"OVER" Category Height for Age Requirements

WEANLINGS - Horses up to and not including 12 months of age shall not exceed 40" in height
YEARLINGS - Horses 12 months up to and not including 24 months of age shall not exceed 42" in height
TWO YEAR OLDS - Horses 24 months up to and not including 36 months of age shall not exceed 44" in height
MATURE HORSES - Horses 36 months and over shall not exceed 46" in height

Entries/Payments: All horses/ponies not registered with AMHS Inc. must have a copy of both sides of the original Registration Certificate accompany the Entry Form with your payment, or the Entry will NOT be accepted and all handlers/exhibitors MUST be AMHS Members. All Entries must be posted (postmarked) or emailed by the advertised closing date. Committee reserve the right to refuse any Entry for any reason.

Registrations: All horses and ponies must hold a current registration with a recognised Miniature Association/Society. Pending Registrations with other Associations/Societies will NOT be accepted. AMHS Pending registrations only accepted if paperwork is with the Registrar.

Membership: ALL competitors and Handlers MUST be a Financial Member of AMHS Inc and present Member card upon request to compete in AMHS Only classes. However if you are not there is the option to pay a '\$15 One Off, One Day Membership'. This is for people to come and compete at our show and see if AMHS Inc is right for you. You then have 3 months to join and that \$15 will be deducted from the cost of your membership.

Measuring: All Horses and Ponies MUST be measured at advertised times unless otherwise arranged with Show Manager due to unforeseen circumstances. For Non-AMHS Registered horses/ponies please bring Original Registration Certificate to measuring so brands and microchips can be checked. At measuring it is the entrant's responsibility to record if your horse/pony has changed classes because of a change in measurement. Any horse/pony not measured prior to the show will not be permitted to enter and will forfeit entry monies paid. Height for age rules does apply on all AMHS Inc shows. The Committee will not be held responsible for any horse/pony that misses a class due to height change. It is a condition of entry that you agree that your horse/pony may be tested for drugs.

Eligibility: Horse must be entered in their respective height for age classes according to their age at 1st August. All horses must show according to the height officially measured. Substitutions will not be accepted. All equipment including halters, sulkies, and harness must conform to safety standards and comply with all insurance obligations.

Protests: General Protests: Any Protest must be submitted in writing and accompanied by a \$50 Protest Fee (which will be refunded if the protest is upheld). Any Protest must be lodged within 30 minutes of the alleged incident. Refer to AMHS Show Rules for further details on Protests. No Protest will be accepted in regards to a horses or ponies height once an AMHS Inc. event commences.

Show Rules: All AMHS Inc. Shows are run in accordance with the AMHS Inc. Constitution and Show Rules. Committee reserve the right to refuse any entry at any time. It is a condition of entry that you accept these rules and will show in accordance with these rules as outlined. Random drug testing may occur. Any person found in breach of these rules may be disqualified and it may also lead to further disciplinary action.
