1. All riders must have a current pony club WA membership or open rider insurance.
2. The organisers have the right to cancel, alter or combine any events they deem necessary on the day.
3. All persons on horseback are required to wear an approved helmet and riding boots.
4. Riders age will be as at the day of the event.
5. No stallions or dogs permitted on the grounds.
6. The judges decision is final.
7. BECP and its committee, judges and officials do not accept and liability for any accidents, loss, damage, illness or injury to horses, owners, riders, spectators or any other persons or property whatsoever. Entry onto our grounds is done at your own risk. Waiver must be signed and sent in with entries.
8. This event is open to unofficial horses/ponies/riders. We aim to have a fun day with a relaxed atmosphere.
9. A horse/rider may only compete in either walk/trot or walk/trot/canter.
10. Entry fees will not be refunded after the closing date unless a medical or vet certificate is provided within 5 days of the completion of the event, in such cases 50% of entry fees will be retained by the club.
11. A limited number of yards are available to be booked in a first come first in basis, horses are permitted to be tied to the float provided the float is attached to a vehicle.
12. All active pony club members must wear their pony club uniform; either casual rally shirts or official jumper. Open riders to wear hacking jackets or neat and tidy long sleeve shirts.
13. Please follow our parking instructions.
