ADULT RIDER -- RISK WARNING - WAIVER OF LIABILITY

I ________(Name) by requesting to participate in the Activities provided by the Equestrian Centre, I acknowledge and agree that I am responsible for my own safety. I acknowledge and agree that nothing done by the Indemnified Entities or Indemnified Persons can reduce my responsibility for myself and my safety.

In signing this Waiver, I acknowledge and agree that:

- there are significant risks associated with being around horses and participating in the Activities which include but are not limited to the following;
- HORSE RIDING AND THE ACTIVITIES ARE VERY RISKY AND A DANGEROUS RECREATIONAL ACTIVITY
- horses are living animals and each horse has a different nature and temperament, which means that horses may act unpredictably at any time without warning and I acknowledge that no warranty or undertaking is given about the suitability of the horse for myself or the appropriateness of the horse for riding by me;
- a horse may behave in such a way that causes injury, loss, damage, disability or death to a rider or person in the vicinity of the horse;
- horses may collide with other horses or objects or fall or stumble which may cause injury, loss, damage, disability or death;
