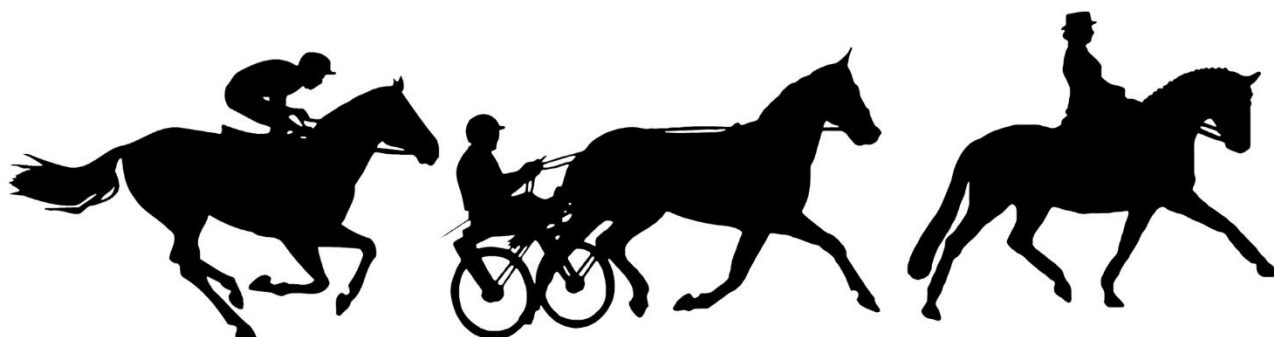

CONDITIONS OF ENTRY – PLEASE READ PRIOR TO ENTERING

- 1. ASSOCIATION LIABILITY:** RWWA/SPPHAWA or any of its agents shall not be liable for any financial loss or damage, physical injury or property damage suffered by any person by reason of any defect, accident, negligence or neglect however arising.
- 2. AUTHORITY OF SHOW COMMITTEE:** The Committee reserves the right to cancel, alter or combine any event they may deem necessary. Any unruly animal will be requested to leave the ring or grounds. (Unruly being at the discretion of the Stewards and Judges).
- 3. CONDUCT:** Competitors shall at all times behave in a proper and respectful manner. Judges should not be approached prior, during or after the competition. Any exhibitor whose conduct is considered to be ill-mannered, aggressive or unsportsmanlike may be issued a warning and subsequently dismissed from the class or disqualified from the show.
- 4. ENTRIES:** Entry fees as set out on the Entry Form will apply. **REFUNDS of entry fees will not be paid unless the event is CANCELLED.** SPPHAWA Inc Committee reserves the right to refuse, cancel or accept conditionally any entry. Exhibitors will not be permitted to compete unless relevant Disclaimer Statement forms are completed correctly and any fees tendered.
- 5. OTT ID PASSPORTS:** Every Standardbred and Thoroughbred entry MUST PROVIDE a copy of the horses OTT ID PASSPORT or proof of application for the entry to be processed. www.offthetrackwa.com.au/off-the-track-wa-passport/
- 6. HORSE REGISTRATIONS:** All Partbred Thoroughbreds must be registered with TPPSWA and be current financial members. Please provide copies of papers and membership card for processing of entry. For registrations please contact tppswa@hotmail.com. All Partbred Standardbreds must be registered with SPPHAWA, please provide copies of papers with entries.
- 7. PRESENTATION:** All Standardbred's and Thoroughbred's must be presented with plaited or hogged manes, braided or pulled/shaved tails with the exception of Race Conditioned, Juniors and Stallions. Partbred Thoroughbreds must be presented with plaited or hogged, braided or pulled/shaved tails with the exception of western disciplines who can be banded/hogged. Suitable and substantial headgear is required on all horses in the led classes. All ridden horses must be fully plaited and ridden in a suitable bridle. Bitless bridles are not accepted. All persons on horseback are required to use a registered standard approved safety helmet.
- 8. SENSORY HAIRS:** *for Standardbreds only*, all sensory hairs must not be removed (whiskers and inner ears). Ears may be neatened but inner hair must not be removed. Please follow the guidelines for you breed or EA\SHC rulings.
- 9. EXHIBIT NUMBERS:** Competitors may not enter any class without their correct exhibit number clearly displayed either on their back or in a number holder.
- 10. STALLION/COLTS:** may not be handled or ridden by any person under the age of 18 years. Stallions must be under control and always supervised. Stallions must be bitted at all times whilst being handled.
- 11. LED & RIDDEN SHOW HORSE/SHOW HUNTER CLASSES:** Horses can only compete in one class, Show Hack OR Show Hunter. If you enter both classes you will not be refunded.
- 12. ELIGIBILITY OF OTT & PARTBRED CLASSIC:** **TO ENTER THE OFF THE TRACK CLASSICS OR THE ULTIMATE PARTBRED THOROUGHBRED YOU MUST COMPETE IN AT LEAST ONE CLASS IN THE LED & RIDDEN SECTION OF THE DUAL-CODE PROGRAM.**
- 13. STANDARDBRED WALK/TROT ELIGIBILITY:** Any Standardbred that has competed in ANY canter classes is not eligible for the Walk/Trot classes in the Dual-Code program and also the Walk/Trot Classic. This includes competing in Dressage (excludes Prep 3) or eventing.
- 14. NEWCOMER/PERFORMANCE HACK CLASSES:** Newcomer classes are for horses who are in their first 12 months of competition. You must have not competed at any show prior to May 13th, 2022. PERFORMANCE (Class 45) is for Thoroughbred horses who regularly compete in other disciplines and not Official Show Horse (e.g., Dressage, Jumping, Eventing)
- 15. SWABBING:** Any exhibit may be randomly selected to be swabbed for prohibited substances throughout the event.
- 16. REFUNDS:** Strictly no refunds unless a vet Certificate is provided prior to the event.

Description of Activities¹: Any equestrian event that is run by SPPHAWA

Risk Warning

I am aware that by my participation in any activities arranged by the Provider, certain risks or dangers may occur which could include:

- Physical, bodily or psychological injury or death.
- Physical exertion to which I am not accustomed.
- Failure of equipment or use of inadequate equipment.
- There may be no or inadequate facilities for treatment or transport to treatment if I am injured.
- The conditions in which the activities are conducted may vary without warning.
- I may cause injury to other persons and/or other persons may cause injury to me.
- I may be injured or die due to the negligence, breach of contract or breach of statutory duty or guarantee of the provider.

I acknowledge that the activities are being undertaken for the purposes of recreation, enjoyment or leisure, and involve a significant degree of risk of physical harm. I acknowledge that the Activity may be undertaken with one or more other persons as part of a group and that the Provider is not liable for the actions of other participants in the group activity.

Participant’s Warranties
