1. The Gosnells Riding and Pony Club Inc would like to welcome all to our Summer Showoffs.
2. **ALL NON EA OR GR&PC MEMBERS MUST PAY THE \$20 DAY MEMBERSHIP FEE (This is for Public Liability Insurance ONLY, NOT Personal Accident Insurance)**
3. The Committee reserves the right to cancel, alter or combine any event they may deem necessary
4. **Stallions and Colts** must be under control at all times and have suitable and substantial headgear and the age of handler must be 18 years of age or over - ie follow all your breed regulation rules
5. **If a stallion gets loose due to the headgear the owner will be held responsible for any and all damages caused.**
6. Handler's age shall be the age on the day of competition.
7. Horses/Ponies with dual registrations may compete in all eligible events AND Other Registered Breeds only if your registration is not covered in any of the rings. This includes height certificates for breeds that they are required and **current memberships**.
8. It is your responsibility to present to the measuring bay, wait for your turn – please be aware there could be stallions and young horses in the queue – please act responsibly, have sufficient control and suitable age of handler **NO bandages and must wear bridle** (if mouthed)
9. **Anyone attending for measuring only are required to present to the clubroom to complete a disclaimer and pay the ground fee of \$20 (this is to include you in our insurance)**
10. **NO PENDING REGISTRATIONS** will be accepted (unless proof of acceptance can be supplied) copies of papers and memberships must be sent with pre-entries and copies to be supplied for viewing with entries on the day.
11. Protests to be submitted 30 mins from the conclusion of the event, in writing with a \$100 fee. Ground jury decision will be final and cannot be protested. Refunds will only occur on the protest being upheld (no discussion/arguing within the rings will be tolerated)
12. **DON'T BE LATE FOR YOUR EVENT!!** We want you to have a good day, so please be aware of the events currently being judged and be ringside in plenty of time to compete and listen to all PA announcements it is your responsibility to check where rings are up too – due to amount of entries breeds time will vary from ring to ring. (Have a runner if in multiple rings – let stewards know you are coming)

1 I, the Entrant, hereby agree with the Organiser/s that I am by this agreement entitled to participate in the Equestrian Activity on the terms and conditions set out in this document.

2 The Organiser/s enter into this agreement on their own account and also as agent for the Associate/s in respect of each acknowledgement, consent, declaration, release and indemnity expressed in this agreement to be given by me to, or made by me in favour of, an Associate (jointly or in an individual capacity).

3 Definitions

(a) **Equestrian Activity/Activities** includes performing, participating or spectating in any capacity, including as a Member, in any activity authorised or recognised by Equestrian Australia (**EA**) or any of its Member Branches (including online and/or at home).

(b) **Organiser/s** means the organiser of the Equestrian Activity and includes EA, the Member Branch (and its affiliated clubs, associations or committees).

(c) **Associate/s** means Associate/s of the Organiser/s, being employees, volunteers, committees, coaches, officials, medical personnel, Members, sponsors, promoters, advertisers, owners and lessees of premises on which Equestrian Activities are held, underwriters and consultants.

(d) **Claim** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising including but not limited to negligence or under the Australian Consumer Law.

(e) **Member** means a Participating Member as defined in the EA Constitution, being any person (Competitors, Participants and Supporters) or association of persons (incorporation or unincorporated) which is under the rules or constitution of a Member Branch, a duly registered and financial member of that Member Branch.

(f) **Member Branches** means Equestrian Victoria, Equestrian NSW, Equestrian Western Australia, Equestrian South Australia, Equestrian Queensland, Equestrian Tasmania and Equestrian Northern Territory.
