- 2. are listed on a DA membership card as being part of a current DA Ltd financial membership (note this information is included in the letter to which the membership card was attached) OR
- 3. have been issued with a current DA Annual Non member Showing ID card

A copy of your DA membership card, AND the letter to which it was attached if point 2 is applicable, must accompany your entry form OR be available for sighting on the day of the show.
